5. Town and Country Planning (Development Management Procedure) (Wales) Order 2012. Under Articles 2C and 2D as modified by Article 2G – installation of a ground mounted solar photovoltaic renewable energy generation system of 8.355MWp installed capacity.

40 year operational period temporary consent required. No change of use from agricultural at Glyngwernen Farm, Felinfoel, Llanelli.

It was agreed to formulate the following response:

- (1) Generally members held a neutral view about the development proposal at this stage, but understood the applicant's desire to diversify the use of the farmland at Glyngwernen Farm.
- (2) The developer be encouraged to enter into a unilateral undertaking agreement with the council for derived community benefit funding in the Swiss Valley Ward.
- (3) A question was raised about the photovoltaic solar panel life expectancy and whether the solar panels were recyclable once they had become redundant or obsolete and that appropriate advice be obtained from the planning consultants.
- 6. Street naming and numbering Development of twenty new dwellings at land off Caegar, Llwynhendy, Llanelli members received correspondence from Carmarthenshire County Council in respect of the naming and numbering of this new development. The county council had suggested to continue the numbering of the existing site of Clos y Berllan, by extending the street numbering sequence to incorporate the new development.

It was agreed to support the suggestion.
