194. GREAT WESTERN RAILWAY POPPIES TO PADDINGTON 10 NOVEMBER, 2023

Cllr. R. E. Evans declared a personal interest in the following item as he was the Chairman, Royal British Legion, Llanelli and an appointed poppy organiser for the Royal British Legion.

Members received correspondence from the Community Engagement and Events Manager, Great Western Railway enquiring if the council would like to participate in the Poppy Train event which would take place on Friday, 10 November, 2023.

During Covid-19 lockdown, Great Western Railway organised a number of 'Poppy Trains' to take wreaths from local communities and deliver them to Paddington Train Station to mark Armistice Day. This meant that communities from across the Great Western network could be represented in the annual service of remembrance at the war memorial at the station.

Following discussion, it was

RESOLVED that the council shall participate in the event with the Chairman of Council presenting a poppy wreath to be transported to London on the 'Poppy Train' for it to be laid alongside wreaths from other communities served by Intercity trains at the war memorial, platform 1, Paddington Station, London.
