437. THE COUNTY OF CARMARTHENSHIRE (IMPOSITION OF 30 MPH SPEED LIMIT) (NO. 2) ORDER 2024

Members received correspondence and a public notice from Carmarthenshire County Council in respect of its intention to introduce a proposed Traffic Order which would impose 30 MPH speed limits in various locations in Carmarthenshire. The Traffic Order also sought to revoke 'The County of Carmarthenshire (Imposition of 30 MPH Speed Limit) Order 2023'; 'The County of Carmarthenshire (B4309 Cwmffrwd to Five Roads and the B4306 Cwmffrwd) (Imposition of 40 and 50 MPH Speed Limit) Order 2013' for certain lengths of road covered by the Order; 'The County of Carmarthenshire (Class III Road, Bwlchnewydd) (Imposition of 40 MPH Speed Limit) Order 2000'; and 'The County of Carmarthenshire (Ty Mawr, Llanybydder) (Imposition of 40 MPH Speed Limit) Order 2004' in their entirety.

RESOLVED that the proposals be supported in the interest of highway safety.
