3. Community Facilities – Maintenance Works.

Report noted.

4. Furnace Community Hall – Storage Area – to consider a letter received from the committee members, Llanelli Woodturning Club for permission to extend and use the storage area at Furnace Community Hall and to agree the council’s response.

Permission was refused on the basis the council had an ongoing need to use the storage area for its own purposes.

5. Trallwm Community Hall – Car Park – to consider email correspondence from Tiny Tots Town requesting permission to use the community hall car park for a fee and to agree the council’s response.

It was agreed to:

- (1) Hold the request in abeyance for the time.
- (2) Officers continue to have discussions with Trallwm Hall Management Committee over the extent of the use of the hall car park by hall patrons.

- (3) If ultimately, there was a general consensus over sharing the hall car park with the patrons of Tiny Tots Town the matter shall be reconsidered by the council with the possibility of creating a business plan to help formulate the agreement premised on parking arrangements at the council's other community facilities, with such an agreement being enacted directly with the council.
6. Dafen Park – Bowls Pavilion – to consider a request received from Dafen Welfare Bowls Club for permission to erect a ramp for disabled access to the pavilion and to agree the council's response.
- Permission be granted to Dafen Welfare Bowls Club to install a disabled ramp at the pavilion at the club's own expense, noting that the club might also need to apply for planning permission to install it depending on whether the proposed ramp was classed as a temporary or permanent structure.
7. Public Bodies (Admission to Meetings) Act, 1960 – it was agreed to exclude members of the public during consideration of the following agenda item because of the confidential nature of the business to be transacted.
8. To receive Statement of Accounts and to consider providing financial assistance to:  
(1) Five Roads Community Hall – 31 March, 2024.
