## 399. LLANELLI INTERCHANGE PUBLIC CONSULTATION – 17 MARCH, 2025 – 18 APRIL, 2025

### 400. TOWN AND COUNTRY PLANNING ACT (1990) APPEAL DECISIONS

### (1) CAS-02292-G1X7P1 – LAND PART OF LLIEDI FACH FARM, FIVE ROADS, LLANELLI

Members received correspondence from Carmarthenshire County Council regarding the outcome of an appeal decision in respect of the change of use of land and buildings from a mixed use of agriculture, for equine and private stables to a mixed use of agriculture, forestry, equine, private stables, resident commercial livery and dressage training facility at land part of Lliedi Fach Farm, Five Roads, Llanelli. The enforcement action had been quashed and the appeal subsequently upheld.

## (2) CAS-03832-Z4K0T5 – PL/06879 – LAND ADJACENT TO TIR ONNEN, FIVE ROADS, LLANELLI

Members received correspondence from Carmarthenshire County Council informing of an appeal decision, against the county council's decision to refuse planning permission in regard to the conversion of an existing outbuilding into separate accommodation (new dwelling), including new access and driveway. The appeal had been dismissed.
