3. Community Facilities – Maintenance Works.

Report noted.

4. Sandy Community Hall – Car Park – to consider correspondence from the Modernising Transport Coordinator, Carmarthenshire County Council and to agree the council's response.

The principle of using Sandy community hall car park by residents during the planned improvement works to the junction at A484 Sandy Road and Maes Y Coed was refused as the use of the hall car park was for hall patrons' only. Several members of the hall management committee including the committee chairman were present during the discussion. To help expedite the decision making process without further seeking the hall management committee's support for refusing the request; the committee chairman requested that in this instance, the council convey this decision to the county council on behalf of the hall management committee, direct.

5. Gwili Fields – to consider the Community Development Officer's email on the community's response for recommendations for a new name for the Gwili Fields and to agree the council's response.

It was agreed that the new name for the Gwili Fields play area in Llwynhendy shall henceforth be known as 'Parc Y Gwili'.

6. Canolfan Llwynhendy Community Building - Targeted Finance Fund – to note for information the decision letter received from Head of Economic Development and Property, Carmarthenshire County Council.

Noted that the council had been awarded £20,000 from the fund to offset first year salary costs of the new post of Community Buildings Manager to manage the Canolfan.
