#### 24. COMMUNITY FACILITIES – MAINTENANCE WORKS

**RESOLVED** that the Facilities Manager's report on work undertaken be noted.

#### 25. PLAY AREAS – VANDALISM

Cllr. D. M. Cundy in his capacity as committee chairman wanted to flag up with disappointment, a concern over two separate acts of recent vandalism at the council's newly installed play areas at Penygraig, Bynea, and at Parc Y Gwili, Llwynhendy. He cited the costs of having to make repairs and was keen to stress this wasn't sustainable for the council in the longer term and in view of this he was keen to garner the views of committee members on how best to combat the problem going forward.

During the ensuing discussion, members cited other play areas that had also suffered some form of vandalism, and they expressed frustration with local communities in not wishing to engage in tackling anti-social behaviour proactively and directly, if witnessed. Members of the public were not so inclined to challenge, and report live incidents. Several reasons were attributed to this, and members concurred that something needed to be done to address this worrying underlying trend. Various counter measures were then discussed, ranging from the installation of CCTV systems; councillor led community engagement initiatives within their wards; developing stronger relationships with neighbourhood policing teams in order to carry out proactive patrols and surveillance especially with PCSOs; and also direct messaging campaigns using social media channels to help rally the community to take greater care and pride in helping to protect important community facilities, and it was

**RESOLVED** that the matter be kept under review.

#### 26. PWLL RECREATION GROUND – MURAL

*Cllr. J. S. Phillips and W. E. Skinner declared personal interests in the following matter as they were members of Pwll Carnival Committee.* 

Members considered correspondence from Cllr. J. Lovell requesting permission from the council for a mural to be painted on a wall of an outbuilding at Pwll Recreation Ground.

If permission was granted, the mural would be painted on the outbuilding wall by a local artist during the planned village carnival on Saturday, 28 June, 2025. The cost of the mural would be met by Pwll Carnival Committee and Pwll AFC. The mural would consist of Pwll AFC logo and local historical images.

Following discussion, it was

**RESOLVED** that the request be supported with permission being granted for the artistic work to proceed on the basis that no objections were received from other stakeholders and that a simple risk assessment be conducted by Pwll Carnival Committee to ensure general public safety before, during and after the planned spray painting work in the vicinity of the outbuilding.

**RESOLVED** that the preferred design selected from the four initial designs be put out to public consultation using the council's social media channels once the sign-writer had drawn up several iterations of the preferred design, for general consideration.
