# 90. PROPOSED 20MPH TO 30MPH SPEED LIMIT INCREASE ON THE B4297 ROAD AT HEOL BWLCH, BYNEA

Correspondence was received from Carmarthenshire County Council informing of the proposed change from 20mph to 30mph speed limit increase on the B4297 road at Heol Bwlch, Bynea. The proposals followed a review of 20mph speed limits in line with Welsh Government guidance and the length of road above had been identified as appropriate for a 30mph. Members felt that as there was a junction on this stretch of road an increase in the speed limit would have an impact on highway safety.

Following discussion it was

**RESOLVED** that an objection would be lodged on the council's behalf.
