### 170. PROCUREMENT OF LAPTOPS

Members received the report of the Finance Manager informing the need for the procurement of computers.

Microsoft had confirmed that support for Windows 10 would end on 14 October 2025. After this date, no further updates or critical security patches were provided, which potentially exposed the council systems to cyber threats. Any resulting breaches were not covered under Cyber Essentials Plus insurance.

A review of staff and learner computers across council service areas had identified 15 computers incompatible with the upgrade to Windows 11. These computers had to be replaced to maintain operational integrity and compliance.

Quotations had been obtained from four suppliers for replacement laptops.

Following discussion, it was

**RESOLVED** that the quotation obtained from Laptops Direct, Trident Business Park, Leeds Road, Huddersfield, West Yorkshire, HD2 1UA, in the sum of £5,373.45 plus VAT be accepted.
