5. Parc Y Gwili and Penygraig Play Areas - Anti Social Behaviour – further to Minute No. 134, to consider a cost analysis report from the Facilities Manager outlining the repair or replacement of damaged items at both play area sites and to agree the council's response.

The cost analysis was noted but going forward members requested a half yearly committee report be presented to committee highlighting the cost of vandalism across council owned community assets.

Officers contact Natural Resources Wales to obtain a view about the flood alleviation measures identified in the scheme provided by Tulip Engineering Consultancy seeking an opinion about the predicted surface water flow rates discharging into the river Dafen. Furthermore whether the general geology and ground conditions in the park naturally created a high water table and whether this might render any potential works ineffective.
